INVESTMENT INFORMATION

NEW ACCOUNTS: New Investors are welcomed. Office hours are from 8:00 a.m. to 12:00 and from 1:00 p.m. until 4:30 p.m. Monday through Friday except for National and State Associational meetings, and calendar holidays. Anyone who would like to help new missions and churches can do so financially by means of opening up an investment account. A new account can be opened by making a personal visit to the Revolving Loan Fund office or by securing a new account form and filling it out and returning it to the Revolving Loan Fund Office with your check of initial investment. Upon receiving your check and filled out investment form and receipt will be sent to you by return mail. Each account will bear the name, birth date, marital status, address, phone number, beneficiary, and social security number of each one listed on the new account form as depositor. The account names cannot be changed without the personal appearance of each person listed or either a notarized document of each depositor giving consent to and acknowledging such change.

INVESTMENTS: Investments can be made by coming into the office or by mail. Upon each investment a receipt will be issued.

INTEREST: Interest rates are variable and determined by the going prime rate and will be re-evaluated by the Revolving Loan Fund Trustees at regular intervals. Should it at any time be necessary to increase or lower the interest rate a notice is mailed to each investor.

WITHDRAWALS: Withdrawals can be made at any time by coming into the office, by phone, or written request. In order to honor a request for withdrawal by phone or in writing. It is required that your social security number and your account number issued to you by the Revolving Loan Fund Office at the time you opened your account be submitted

PENALTIES: There is no time limit or penalty for withdrawals.

SECURITY: We are not a FDIC insured investment agency. Our finances are secured by net assets and collaterals owned by the RLF of the BMA of Mississippi.
